

## **SUPPLEMENT # 3 TO AVAWATZ COMPANY**

**CONFIDENTIAL PRIVATE PLACEMENT MEMORANDUM DATED APRIL 1, 2024**

**THE DATE OF THIS SUPPLEMENT IS July 29, 2024**

This Supplement # 3 to Confidential Private Placement Memorandum (this “Third Supplement”) supplements the Confidential Private Placement Memorandum of AvaWatz Company, a corporation incorporated in the State of Texas, dated as of April 1, 2024 (the “PPM”), as supplemented by the First Supplement dated May 28<sup>th</sup>, 2024 (the “First Supplement”), and the Second Supplement dated June 28<sup>th</sup>, 2024 (the “Second Supplement”). The purpose of this Third Supplement is to extend Offering Period 1 of the Perks Program, during which a 25% discount is applied to the share price, to October 31, 2024.

This Third Supplement is incorporated by reference into, and should be read in conjunction with, the PPM, the First Supplement, and the Second Supplement. This Third Supplement is not complete without and may not be delivered or utilized except in connection with the PPM, the First Supplement, and the Second Supplement.

By accepting or reviewing this Third Supplement, you agree to hold all information contained herein in the strictest confidence and not to use this information for any purpose other than to analyze an investment in the Company. Failure to comply with this directive can result in a violation of the Securities Act of 1933, as amended, and rules and regulations promulgated thereunder. Any further distribution or reproduction of this Third Supplement or the PPM or the First Supplement or the Second Supplement in whole or in part, or the disclosure of any of its contents by an offeree, is unauthorized.

Capitalized terms used but not defined herein shall have the meanings given to them in the PPM.

Except as expressly set forth in this Third Supplement, the PPM, including all disclosures therein and all exhibits thereto, will continue unmodified.

### **Modification of the Offering Period 1 of the Perks Program**

The PPM originally stated that the Offering Period 1 of the Perks Program was to expire on May 31, 2024. The First Supplement supplemented the PPM to state that the Offering Period 1 of the Perks Program will be extended to expire on June 30, 2024, unless extended in the sole discretion of the Company. The Second Supplement supplemented the PPM and the First Supplement to state that the Offering Period 1 of the Perks Program will be extended to expire on July 31, 2024, unless extended in the sole discretion of the Company. The PPM, the First Supplement, and the Second Supplement is hereby supplemented to state that Offering Period 1 of the Perks Program will now expire on October 31, 2024, at 11:59 p.m. Pacific Time, unless extended at the sole discretion of the Company. Accordingly, Offering Period 2 of the Perks Program will now commence on November 1, 2024, at 12:00 a.m. Pacific Time.
